

Special City Council Election to be Held Nov. 8

North Richland Hills is holding a special election on Nov. 8 to fill an unexpired term for City Council Place 5. Candidates are: Jared Ross; Paul Epperley; Blake Vaughn; and Joey Ballard.

The person duly elected shall serve the remainder of the term, which expires in May 2023. To review each candidate's application form, visit www.nrhtx.com/election and click on Candidate Filings/Finance Reports. You are welcome to contact each candidate directly to learn more about them.

Have Flooding Concerns? Contact NRH Public Works

Did you know the North Richland Hills Public Works Department provides determinations on whether a property is located within a Special Flood Hazard Area? Information is also available on:

- Flood insurance data such as the FIRM Zone, Base Flood Elevation (BFE) and the location of floodways
- Little Bear Creek Corridor's natural floodplain protection regulations
- Elevation Certificates that have been processed in North Richland Hills
- Historical flooding or drainage problems throughout the city

NRH Public Works staff will make site visits to review flooding and drainage problems for property located within the city limits. These services are offered free of charge. For more information, please contact the NRH Public Works Department at 817-427-6400.

Good Neighbor Tip: Fences

Fences provide us with a sense of privacy and security. They may also reduce noise and enhance the appearance of a property. Deteriorating fences may give unwanted persons access to your property or allow pets to escape and roam the neighborhood. Please be a good neighbor and properly maintain your fence.

City ordinance requires you to repair, replace or remove a fence that is severely deteriorated or leaning 15 degrees or more. Missing or deteriorated fence panels, slats, rails, pickets and posts must be replaced with material similar in size and appearance to those being replaced. If installing or replacing 4 or more fence panels, you will need a building permit, which helps protect your family from poor construction and safety risks. Permits can be obtained online at www.nrhtx.com/eportal.
