## Call for Arts & Craft Vendor's

---

Planning is underway for the 2019 NRH Holiday Magic.

NRH Holiday Magic will be held on **Friday, December 6, 2019 from 6:00 to 9:00 p.m.** in an “entertainment district” created along Hawk Avenue, Grand Avenue and the Library parking lot.

We are seeking **arts and craft vendors presenting original or handmade work!** This is a juried show; jury considerations include: quality, originality, how your items are represented and our need to diversify the arts and crafts available at Holiday Magic. The Holiday Magic Committee reserves the right to limit the number of crafters/artists in a particular category, i.e. jewelry. We strive to provide a varied group of crafters/artists and try not to duplicate “like” items.

If you would like to be considered as an Arts & Craft Vendor for the 2019 Holiday Magic, please review the following information and complete the Arts & Craft Vendor Application.

### **A LITTLE ABOUT HOLIDAY MAGIC:**

This is the 20<sup>th</sup> year for the City of North Richland Hills’ annual Christmas tree lighting ceremony and much more... including holiday music, entertainment on two stages, photos with Santa, tree lighting, fireworks show, holiday shopping, children’s activities, food vendors and more. There are multiple holiday scenes that provide great backdrops for fun family photos or for holiday family portraits. Parking is free at HealthMarkets. Children's craft activities \$3.00.

## ARTS & CRAFT VENDOR INFORMATION:

1. **Craft Vendor Information:** Each interested vendor must submit an Arts & Crafts Vendor Application, a color photo of the vendor's setup, a current color photo of products to be offered for sale and a general list of craft items to be sold, including prices. Applicants must also submit a check to cover booth fees to participate in the event. All completed applications will be reviewed and selected by the 2019 Holiday Magic Committee based on quality, originality, how your items are represented and our need to diversify the arts and crafts available at HM. The Holiday Magic Committee reserves the right to prohibit the sale of items it deems inappropriate for this event.
2. **Craft Booth Fees: \$60.00** - All booths are 10' wide by 10' deep and will be set side by side in a row with access from one side only. If your booth requires more than one side to be open for customer access, please let me know and I will try and put you in a location to accommodate this. The 2019 Holiday Magic Committee will assign all booth locations. You can request a specific location, but this is not guaranteed.
3. Once you have been chosen to participate, no refunds will be given. Arts & craft vendors not chosen to participate will have their checks returned to them by mail. In the event of inclement weather, a portion of the event may move indoors and arts & craft vendors will have the option of participating or having their fees refunded, depending on the severity of the inclement weather.
4. All arts & craft vendors must be registered with the State of Texas and possess a Texas Sales Tax Permit.
5. **The City of North Richland Hills will provide the following:**
  - One 10' x 10' booth space
  - One electrical outlet from a generator
6. **All arts & craft vendors are required to provide the following for the operation of their booth:**
  - WHITE 10' x 10' tent
  - Weights for your tent
  - Tables and chairs
  - One orange electrical cord, at least 50', labeled with your name
  - **LED lights** for night time operations (LED Lights Only – No Exceptions)
  - Any other items necessary for the operation of your booth

**Note:** All tents will be the color white and in good condition. If you choose to use sides on your tent, they must be appropriate for use with your tent. No sheets or colored tarps. Booths will be tastefully decorated with no hand written signs.

7. **Electricity:** One electrical outlet will be provided for each craft booth. The vendor is responsible for providing one orange electrical cord labeled with your name. You must provide your own LED lighting for night time operations. **LED lights are REQUIRED** to be used as they pull fewer amps from the generators. **If your booth requires more electricity than provided you must provide your own generator. If you do not provide your own generator and use something other than LED lights, your lights will be disconnected from the City's generator.**
8. **Set-up Time:** **Set-up time will be from 1:00 p.m. to 5:00 p.m. on Friday, December 6, 2019. All vehicles must be out of the loading/unloading area by 4:00 p.m. (NO EXCEPTIONS)** Parking will be provided at the NRH Centre, SEY-TEC lot directly north of the NRH Centre or Walker Creek Elementary. The unloading area will be monitored. Even though the event does not begin until 6:00 p.m., participants will begin arriving as early as 5:00 p.m., so all vendors must be set up by 5:00 p.m. with all vehicles moved to the designated parking areas by 4:00 p.m.
9. Craft booths may not serve any food or drinks unless a Food Vendor Application has been completed, approved and the booth has been inspected and permitted.
10. **Applying for an Arts & Crafts Vendor booth for the 2019 Holiday Magic does not guarantee a space at the event. All completed applications will be reviewed by the Holiday Magic Committee, and vendors will be selected based on Committee decision.**

**All applications must be submitted no later than November 8, 2019.**
